I furthermore undertake to comply with all applicable laws and regulations, including the laws and regulations applicable to the driving of motor vehicles (the German Road Traffic Regulations), and to bear full responsibility in the event of a violation of said law or said regulation, including the payment of fines and fees incurred in accordance with the applicable laws.

I agree to indemnify and hold Pirelli harmless from and against any and all liability whatsoever arising out of or in any way in connection with my participation in the event, both during the road tour(s) and during the circuit laps, and I hereby waive any liability claim and enforcement against Pirelli through the initiation of court proceedings in this regard.

This declaration shall be governed by and construed in accordance with German law. Any dispute arising out of or in connection with this declaration, including its interpretation, enforceability, execution, dissolution or termination, in which the parties involved in it cannot mutually agree, shall be referred to the state jurisdiction where I reside or establish my domicile, or, at my choice, the registered office of Pirelli, except in cases where Pirelli is summoned by a third party for an event covered by this declaration and which relates to me, in another court, then I may also be summoned by that other court.
