

P ZERO™ EXPERIENCE REGULATIONS
Hockenheimring
14TH October 2021

The following regulations must be complied with in order to have access to the Circuit and the paddock at Hockenheimring Baden-Württemberg, Am Motodrom - 68766 - Hockenheim hereinafter "**Circuit**") and to be able to use the purchased PZERO Experience Package:

1. REQUIREMENTS FOR ACCESSING THE CIRCUIT AND PROHIBITIONS
CONCERNING THE Paddock

Prior to the start of the PZERO Experience, each driver (within the meaning of these regulations, "driver" is the natural person who purchased the PZERO Experience Package and drives the vehicle on the Circuit - as defined in section 1.1 - on the Circuit) is provided with the programme of activities and technical briefing, which is required in order to be able to drive on the Circuit. The driver must follow the instructions of the person responsible for the circuit activities and the personnel appointed by Pirelli.

1.1 In order to take part in the driving event, each driver must:

- (a) be at least 21 years old and hold a licence authorising them to drive vehicles issued at least 36 months previously and not subject to suspension or any other penalty;
- (b) ensure that the vehicle used during the PZERO EXPERIENCE (hereinafter referred to as the "Vehicle") conforms with all applicable legislation, including the necessary tests required under applicable legislation;
- (c) ensure that the Vehicle does not have an unapproved spare part of the component and/or a component not specified in the vehicle registration certificate (logbook) (if necessary);
- (d) ensure that the Vehicle has a maximum sound pressure level of 98 dB;
- (e) ensure that the Vehicle has the legally required mandatory insurance cover with suitable maximum amounts;
- (f) wear helmets and seat belts on the Circuit
- (g) have signed the exclusion of liability documents (provided by Pirelli)
- (h) if taking part in a private vehicle registered by a third party, must have a written declaration authorising him to drive it, which is signed by the registered vehicle owner (as indicated in the logbook/vehicle registration certificate).



1.2

The driver confirms that a maximum of three companions with a minimum age of 14 years are permitted, one of whom must be at least 18 years old. Minors must be accompanied by an adult and legal guardian in order to have access to the Circuit and paddock. Only those companions who are at least 21 years old may take part in test drives with a vehicle from the carmakers and partners of the Pirelli P ZERO Experience Test Drives.

1.3

The driver undertakes to ensure that the companions comply with the applicable parts of these Pirelli regulations and the general guidelines of the Circuit at the Red Bull Ring

1.4

Until the driving activities are completed, it is strictly forbidden for drivers to enter the Circuit and/or the paddock in a psychologically altered state (for example, because they have consumed alcoholic beverages or drugs that can reduce concentration/induce drowsiness)

1.5

It is strictly forbidden for the driver to use a vehicle on the Circuit other than that specified on the website and the access ticket.

1.6

It is strictly forbidden for drivers to carry passengers in vehicles taking part in the driving session.

1.7

It is strictly forbidden for companions up to the age of 21 to enter the Circuit.

1.8

It is strictly forbidden for drivers and their companions to bring animals on to the Circuit or the paddock.

1.9 The driver undertakes to dispose of waste oil only in the designated waste oil containers on the Circuit.

1.10

The PZERO Experience Package is purchased individually and personally; it must not be passed on to third parties in any way.

1.10

Outside the Circuit, it is strictly forbidden for the driver to exceed the maximum speed of 30 km/h with his Vehicle.

Drivers must be at least 21 years old to take part in the driving sessions on the Circuit.

2. RIGHT OF EXCLUSION

2.1

PIRELLI reserves the right to exclude from taking part in the PZERO Experience any driver who has not complied with the provisions of paragraph 1, has made false statements or has not submitted the documents requested for the registration process or does not possess the necessary qualifications.

2.2

In the event of serious or repeated breaches of the instructions of the appointed PIRELLI personnel and/or the Circuit or repeated conduct which could impair the safety of the activities and/or the proper provision of the services to the other persons taking part, those persons responsible for this conduct may be excluded from the Programme activities. In the event of this "disciplinary" exclusion, the amount paid will not be refunded.

3. COSTS NOT INCLUDED

Meals and accommodation costs of any kind, costs for additional services, costs for travel to and from the Circuit, fuel, maintenance and insurance costs for the vehicles and all costs not expressly stated in the terms and conditions of sale of the PZERO Experience Package are not included in the registration costs.

5. DRIVER'S LIABILITY

5.1

The driver assumes full liability in all eventualities for the accuracy of the information provided at the time of registration and at any subsequent request from PIRELLI, the Circuit and/or the operators of the PZERO Experience.

5.2



The driver takes part in the PZERO Experience at his own risk. The vigilance of PIRELLI personnel and the Circuit during the activities shall in no way constitute an assumption of liability by the personnel concerned or by PIRELLI for damage caused or suffered by the driver.

5.3

In civil, criminal or administrative proceedings without exclusion or exception, the driver assumes all liability for damage to property or persons, including the goods transported, and for infringements of the applicable regulations as a result of the use of the vehicles concerned.

5.4

The driver undertakes to reimburse the amounts requested by him directly or otherwise, or that the driver can be sentenced to payment in consequence of accidents, incidents or violations as stated above.

OUR SAFETY AND HYGIENE MEASURES FOR PREVENTION OF COVID-19

UPDATED AS OF MARCH 2021*

- **Body temperature, social distancing and face masks:**
 - The body temperature of each participant will be taken at the entrance of the circuit and prior to lunch time. In case the body temperature exceeds 37,3°C, at the entrance of circuit, the participant will not be allowed to attend the Event. In case the body temperature exceeds 37,3°C prior to lunchtime, the participant will not be permitted to attend the Event further.
 - A minimum distance of 2 meters must be kept in all areas of the circuit and respective facilities, including the paddock and the pits.
 - In any case groups of more than 10 people are forbidden.
 - Pirelli will provide face masks and FFP2 masks. It will be mandatory to wear always face masks, in all parts of the circuit and respective facilities, including the paddock and the pits respecting a minimum distance (2 meters) between people.
 - The participant who is driving his/her own car on track (only 1 person per car allowed) must wear the balaclava and helmet. In this case it's not necessary to wear the mask.
 - During the test drives/hot laps on track and/or on road 2 persons (participant + driving instructor) are allowed to be together in the car. In this case the participant must wear the balaclava, helmet and FFP2 mask.
- **Welcome & Technical Briefing:** The participants will be divided in 2 groups in order to guarantee a safety distance of at least 2 meters between the participants. In order to avoid gatherings during the event area, adequate management and surveillance will be guaranteed.
- **Health and safety products provided by Pirelli:**
 - Hydro-alcoholic gel
 - Face masks
 - Latex gloves
- A dedicated person from Pirelli will be at your disposal during the whole day and ensure the compliance with the given safety and hygiene measures.



- Signs containing information on social distancing and mandatory face masks will be located in visible areas at every entrance, as well as in various areas of the facilities.

****The participants acknowledge and agree that Pirelli reserves the right to modify the aforesaid measures at any time prior or during the Event and that strict compliance with the aforesaid rules is a mandatory condition for each participant.***
