

## PZERO EXPERIENCE REGULATIONS MUGELLO CIRCUIT 12<sup>th</sup> – 13<sup>th</sup> June 2021

In order to access the track and paddock in the Mugello Circuit (Autodromo Internazionale del Mugello) in Via Senni, 15 I - 50038 Scarperia e San Piero (FI) (hereinafter, the "Circuit") to use the PZERO Experience Package acquired, the following regulations must be respected:

### 1. REQUIREMENTS FOR ACCESS TO THE TRACK AND PADDOCK -

#### **PROHIBITIONS**

Before the start of each PZERO Experience, each Driver (where, for the purposes of these regulations, "**Driver**" means the natural person who has purchased the PZERO Experience Package who will drive the vehicle - stated in the registration/purchase phase - at the Circuit), will be provided with the programme of activities on the track with which they must comply. Each Driver must comply with the instructions provided by the person in charge of track activities and the personnel appointed by PIRELLI.

#### 1.1

To be able to participate in the track driving sessions, the Driver must:

- (a) have at least 21 years of age and hold a licence entitling them to drive vehicles, currently valid, issued at least 36 months earlier, not subject to suspension or other sanctioning measure;
- (b) guarantee that the vehicle used during the PZERO Experience (hereinafter, the "Vehicle") is is the same selected during the registration / purchase phase on the site dedicated to the sale of the P ZERO <sup>TM</sup> Experience and that compliant with all the legal provisions in force, including having passed any necessary tests required by current legal regulations;
- (c) guarantee that the Vehicle does not have any non-approved replacement part of component, and/or any such component not specified in the vehicle registration certificate (log book) (where necessary);
- (d) guarantee that the Vehicle has the obligatory insurance cover required by law, with adequate maximum amounts;
- (e) wear the specific helmet for motor vehicle use with valid approval, and must wear the seat belts;
- (f) have signed the "General Regulations of the Mugello Circuit"; [MKI1]
- (g) have signed the assumption of liability document (provided by) the Circuit and by PIRELLI;



- (h) have signed the safety and hygiene measures for the prevention of Covid-19;
- (i) having signed the anti-Covid declaration;
- (j) if they are participating with a private Vehicle registered to a third party, produce a written declaration authorising them to drive it, signed by the registered owner of the Vehicle (as stated in the log book/vehicle registration certificate).
- **1.2** It is strictly prohibited for Drivers to access the track and/or paddock in a psychically altered state (merely as an example, due to having consumed alcoholic drinks or drugs that can reduce concentration/induce sleepiness), until the driving activities have concluded.
- **1.3** It is strictly prohibited for Drivers to use a vehicle other than that indicated in the Pass to be shown upon entry.
- **1.4** It is strictly prohibited for Drivers to transport passengers in vehicles engaged in track sessions.
- **1.5** The PZERO Experience Package is purchased on an individual and personal basis; it may in no way be transferred to third parties.

#### 2 COMPANIONS

- **2.1** The Driver expressly acknowledges and accepts that:
  - (i) the maximum number of companions is 3 (three),
  - (ii) children under 14 are not allowed to access to the P ZERO TM Experience and
  - (iii) in the event that the companion(s) are minors (i.e. from 14 to 17 years old), a supervising adult companion must also be present (included in the maximum number of 3 accompanying persons).
- **2.2** The Driver agrees that they shall enforce that their companion(s) will respect, under penalty of exclusion from the P ZERO Experience pursuant to art. 3.1, these Regulations and the "General Regulations of the Mugello Circuit" that apply to them (merely as an example but not limited, as regards to the "General Regulations of the Mugello Circuit", section 2 containing "Obligations, Prescriptions and Prohibitions")

#### 3 RIGHT OF EXCLUSION



**3.1** PIRELLI reserves the right to exclude from participation in the P ZERO Experience any Driver who does not respect the provisions of paragraph 1 and/or paragraph 2, has made false statements or not presented the documentation requested for the registration process, capable of proving their possession of said requirements, or whose vehicle does not match the description in the "Pass" to be shown upon entry. PIRELLI also reserves the right to exclude from the participation those accompanying persons who do not have the requisites referred to in Articles 2.1 and 2.3 and / or do not comply with the "General Regulations of the Mugello Circuit",

#### 3.2

At any time, for serious or repeated breaches of the instructions received from the appointed personnel of PIRELLI and/or the Circuit, or for repeated behaviours that might compromise the safety in the activities and/or the correct delivery of the service to the other participants, persons responsible for such behaviour may be excluded from the programmed activities. In case of this "disciplinary" exclusion, there will be no reimbursement of the amount paid.

#### 4 COSTS NOT INCLUDED

Board and lodging costs of any kind, costs for extra services, costs of travelling to and from the Circuit, fuel, maintenance and insurance costs for own vehicles and all those costs not specifically mentioned in the terms and conditions of sale of P ZERO Experience Packages are not included in the registration cost.

#### 5. LIABILITIES OF THE DRIVER

#### **5.1**

The Driver assumes full liability, in all eventualities, for the truthfulness of the information provided at the time of registration and in any subsequent request made by PIRELLI, the Circuit and/or the operators of the P ZERO Experience.

#### 5.2

Participation in the P ZERO Experience is at the (Driver's) own risk. The vigilance of the staff of Pirelli and of the Circuit during the activities in no way constitutes assumption of liability by the personnel in question or by PIRELLI for any damages caused by the Driver and/or his/her companions.

#### 5.3



The Driver assumes any and every liability, without exclusion or exception, in civil, criminal or administrative proceedings, for any damage to things or to people, including those transported, and for any breach of the current regulations as a result of the use of the vehicles in question.

The Driver undertakes to pay directly or, otherwise, to reimburse the sums requested of them, or that
the Driver might be sentenced to pay as a result of accidents, incidents, or breaches as stated above.

# OUR SAFETY AND HYGIENE MEASURES FOR PREVENTION OF COVID-19 UPDATED AS OF FEBRUARY 2021\*

#### Body temperature, social distancing and face masks:

- o The body temperature of each participant will be taken at the entrance of the circuit and prior to lunch time. In case the body temperature exceeds 37,3°C, at the entrance of circuit, the participant will not be allowed to attend the Event. In case the body temperature exceeds 37,3.°C prior to lunchtime, the participant will not permitted to attend the Event further.
- o A minimum distance of 2 meters must be kept in all areas of the circuit and respective facilities, including the paddock and the pits.
- o In any case groups of more than 10 people are forbidden.
- o Pirelli will provide face masks and FFP2 masks. It will be mandatory to wear always face masks, in all parts of the circuit and respective facilities, including the paddock and the pits respecting a minimum distance (2 meters) between people.
- The participant who is driving his/her own car on track (only 1 person per car allowed)
   must wear the balaclava and helmet. In this case it's not necessary to wear the mask.
- During the test drives/hot laps on track and/or on road 2 persons (participant + driving instructor) are allowed to be together in the car. In this case the participant must wear the balaclava, helmet and FFP2 mask.
- Welcome & Technical Briefing: The participants will be divided in 2 groups. The technical briefing will take place in the pressroom of the circuit in order to guarantee a safety distance of at least 2 meters between the participants. In order to avoid gatherings during the event area, adequate management and surveillance will be guaranteed.

#### Health and safety products provided by Pirelli:

- Hydro-alcoholic gel
- o Face masks
- Latex gloves
- A dedicated person from Pirelli will be at your disposal during the whole day and ensure the compliance with the given safety and hygiene measures.
- Signs containing information on social distancing and mandatory face masks will be located in visible areas at every entrance, as well as in various areas of the facilities.



\*The participants acknowledge and agree that Pirelli reserves the right to modify the aforesaid measures at any time prior or during the Event and that strict compliance with the aforesaid rules is a mandatory condition for each participant.
