PZERO EXPERIENCE PACKAGE

PIRELLI REGULATIONS

In order to access the track and paddock in the Hockenheimring Baden Wuerttemberg Am Motodrom - 68766 - Hockenheim (hereinafter, the "Circuit") to use the PZERO Experience Package acquired, the following regulations must be respected.

1. REQUIREMENTS FOR ACCESS TO THE TRACK AND PADDOCK - PROHIBITIONS

Before the start of the P ZERO™ Experience, each Driver (where, for the purposes of these regulations, "Driver" means the natural person who has purchased the PZERO Experience Package who will drive the vehicle - stated in the registration/purchase phase - at the Circuit), will be provided with the programme of activities on the track with which they must comply. Each Driver must comply with the instructions provided by the person in charge of track activities and the personnel appointed by PIRELLI.

1.1

To be able to participate in the track driving sessions, Driver must:

- (a) hold a licence entitling them to drive vehicles, currently valid, issued at least 36 months earlier, not subject to suspension or other sanctioning measure;
- (b) guarantee that the vehicle used during the PZERO Experience (hereinafter, the "Vehicle") is compliant with all the legal provisions in force, including having passed any necessary tests required by current legal regulations;
- (c) guarantee that the Vehicle does not have any non-approved replacement part of component, and/or any such component not specified in the vehicle registration certificate (log book) (where necessary);
- (d) guarantee that the Vehicle has a maximum sound pressure level of 98 dB;
- (e) guarantee that the Vehicle has the obligatory insurance cover required by law, with adequate maximum amounts;
- (f) wear the specific helmet for motor vehicle use with valid approval, and wear the seat belts;
- (g) respect the regulations of the Circuit
- (h) have signed the assumption of liability document provided by PIRELLI;
- (i) if they are participating with a private Vehicle registered to a third party, produce a written declaration authorising them to drive it, signed by the registered owner of the Vehicle (as stated in the log book/vehicle registration certificate).

1.2

The Driver undertakes to ensure that those accompanying them respect those parts of these Pirelli Regulations and the regulations of the Circuit that apply to them.

1.3

It is strictly prohibited for Drivers to access the track and/or paddock in a psychically altered state (merely as an example, due to having consumed alcoholic drinks or drugs that can reduce concentration/induce drowsiness), until the driving activities are finished.

1.4

It is strictly prohibited for Drivers to use a different vehicle on the track than the vehicle indicated on the website and the Pass / Admission Ticket to be shown upon entry.

1.5

It is strictly prohibited for Drivers to transport passengers in vehicles participating in track sessions.

1.6

It is strictly prohibited for those accompanying the Driver to access the track.

1.7

It is strictly prohibited for the Driver and for those accompanying them to bring any animal to the track and paddock.

1.8

It is strictly prohibited for the Driver to exceed, driving the Vehicle outside the track, the maximum speed of 30 km/h.

1.9

The Driver undertakes to dispose used oil only in the designated waste oil containers present at the Circuit.

1.10

The PZERO Experience Package is purchased personally and only for individual use; it may not be passed on to third parties in any way.

1.11 Minors under 5 are not allowed to participate at the P ZERO Experience. Minors must be accompanied by an adult person with supervisory authority in order to have access to the racetrack and paddock.

1.12 Drivers must be at least 25 years old to attend the driving sessions on the track.

2. RIGHT OF EXCLUSION

2.1

PIRELLI reserves the right to exclude any driver from participation in the PZERO Experience if they fail to comply with the provisions of Paragraph 1, have provided false information or have not submitted the documentation requested for the registration process, do not possess the required documents or whose vehicle does not correspond to the description in the "Pass / Admission ticket" to be shown upon entry.

2.2

In the event of serious or repeated violations of the instructions of PIRELLI's appointed personnel and/or the racetrack, or of repeated actions which could affect the safety of the activities and/or impair the proper performance of the services provided to the other participants, persons responsible for this behaviour may be excluded from the programme activities. In the event of this "disciplinary" exclusion, the amount paid will not be refunded.

3. CANCELLATION

PIRELLI reserves the right to cancel the date on which the PZERO Experience will take place for organisational, safety, or weather-related reasons, due to orders issued by authorities, or if the Circuit should have become unavailable and/or for any force majeure reason. In this eventuality, the Driver will not be entitled to reimbursement of the sum paid.

4. COSTS NOT INCLUDED

Board and lodging costs of any kind, costs for extra services, costs of travelling to and from the Circuit, fuel, maintenance and insurance costs for the Vehicles and all those costs not specifically mentioned in the terms and conditions of sale of PZERO Experience Packages are not included in the registration cost.

5. LIABILITIES OF THE DRIVER

5.1

The Driver assumes full liability, in all eventualities, for the truthfulness of the information provided at the time of registration and in any subsequent request made by PIRELLI, the Circuit and/or the operators of the PZERO Experience.

5.2

Participation in the PZERO Experience is at the (Driver's) own risk. The vigilance of the staff of PIRELLI and of the Circuit during the activities in no way constitutes assumption of liability by the personnel in question or by PIRELLI for any damages caused or suffered by the Driver.

5.3

The Driver assumes any and every liability, without exclusion or exception, in civil, criminal or administrative proceedings, for any damage to things or to people, including those transported, and for any breach of the current regulations as a result of the use of the vehicles in question.

5.4

The Driver undertakes to pay directly or, otherwise, to reimburse the sums requested of them, or that the Driver might be sentenced to pay as a result of accidents, incidents, or breaches as stated above.
